About the information you provide

Deciding whether you are eligible for a change in conditions

Cook Islands Immigration collects the information about you on this form to decide whether you are eligible for a change in conditions. Collecting the information is authorised by the Cook Islands Immigration Act 2021 and the Immigration Regulations made under that Act. You do not have to provide the information, but if you do not, we are likely to decline your application.

Other documents we may need

Sometimes we may ask for additional documents or information to consider with an application. You may wish to send other documents or information so that we can consider it with this application. Send photocopies only (not original documents), as these documents will not be returned to you.

If we need to see an original document, we will ask you to produce it later.
